PASTOR RIPPLES

Grace to you and peace from God our Father and the Lord Jesus Christ.

A couple years ago when our older son was about 6 months old, Stephanie and I began saying the Lord's Prayer as part of his night time ritual. We began doing this because anytime is a good time to pray the Lord's Prayer, and we also did this in order to begin teaching him how to pray our Lord's Prayer. Our son is now 2 ½ years old and he is beginning to recognize that when he hears: "Our Father, who art in heaven..." that he is to fold his hands and pray. This makes me so proud as a parent and as a pastor. But a couple of months ago I realized that at my son's bedtime, I was saying the Lord's Prayer but I wasn't praying the Lord's Prayer. Has that ever happened to you? Have you ever simply said the Lord's Prayer because it is a routine or a habit for you, but you weren't actually focusing on the words that were coming out of your mouth? I'm going to guess for most of us the answer is yes. When things like the Lord's Prayer are recited so frequently (every worship service), it gets committed to our memory (which is a good thing), but then we also begin saying the prayer without even thinking about what it is that we are saying.

Beginning in February, we are going to change we are going to begin our focus during Lent on the Lord's Prayer. This prayer that Jesus taught his disciples is only 70 words long, but most of us are saying the 70 words in the Lord's Prayer, not praying those 70 words to God. Each week during our Mid-week Lenten Eve worship service (including

Ash Wednesday and Maundy Thursday), we will focus on a small portion of our very well-known Lord's Prayer. By focusing on a small phrase of the prayer, I hope that this will help all of us (including myself) gain a better understanding of the words that routinely come out of our mouths when we begin saying "Our Father, who art in heaven..."

As we begin the 40 days of Lent, may we turn our focus to our own prayer life and how Jesus would like us to pray. During Lent we will not sing or say Alleluia, but rather focus on our sin and how we have fallen short of God's glory. We have all made mistakes and have turned our focus away from God from time to time (including saying, but not praying the Lord's Prayer). Let's come before God this Lent confessing our sins and praying for God's merciful forgiveness.

PASTOR ERIC'S RIPPLES

The early followers of Jesus spent much time in the temple...praising God. (Acts 2:46-47)

This means that one of the things they were doing was praying. We have talked about sharing, rejoicing and fellowshipping, now we want to look at prayer.

God really wants us to pray. It is how we maintain a close relationship with God. And so a lot of our worship is prayer. And so we pray around our meals. And so we pray when we need help, and for our family and friends. And so we pray in the morning and we pray in the evening. James writes, "Are any among you suffering? They should pray. Are any cheerful? They should sing songs of praise. Are any among you sick? They should call for the elders of the church and have them pray over them..." (James 5:13-14)

When my dad was getting quite weak from cancer people would come by and visit him. One time one of them was going to pray for him and he told my dad to sit down so he would not get too tired. My dad told him he was going to stay standing and that his friend should remember that God hears short prayers just as good as long ones. This reminds me of what Jesus said right before he taught the disciples how to pray, "When you are praying, do not heap up empty phrases as the Gentiles do; for they think that they will be heard because of their many words. Do not be like them, for your Father knows what you need before you ask him" (Matthew 6:7-8)

So we don't need to pray long prayers listing all our needs and requests. On the other hand, Jesus would sometimes go off by himself to pray for hours at a time. "One of those days Jesus went out to a mountain to pray, and spent the night praying to God." (Luke 6:12) What sort of prayers was Jesus praying? Talking to God, thinking about God, listening to God, daydreaming? Probably all of these things. And, what it did was refresh him, strengthen him, guide him and motivate him. Our lives can be so full, and busy and complicated with so many distractions and commitments how can we possibly spend much time in prayer or even focus or concentrate for very long? And yet, if we don't, how can we order and prioritize the complexity. How do we get refreshed and motivated? And where do we get guidance and strength?

Lately for my daily prayer time it has been helpful to focus in five areas: 1...confession. 2...people. 3...praise/thanks. 4...church/world. 5...listening in silence, picturing God in my mind, waiting for a word. Each day is different in terms of which subject takes up more of the time, and which subject I start with and end with. And yes, some days (many days) I forget and most days I don't even make it to the end, but like I used to say to my kids, don't be like me.

WEATHER CANELLATION POLICY CIRCLE OF FAITH



While we believe in the importance of regular worship and bible study, we also value the lives of our brothers and sisters in Christ. Therefore, the following policy is in place for all of the Circle of Faith Parish congregations when the weather deems it necessary to cancel or postpone events at any of our churches.

In the event of severe weather conditions or other emergency conditions, the Lead Pastor will make any final decision on closing the parish office, canceling or postponing events. For situations that effect a weekday and the status of the parish office, the Lead Pastor will contact all Circle of Faith Parish pastors and employees. A decision will be made based on the current and future forecasted weather conditions.

For weekday events:

A decision regarding morning activities will be made no later than 7:00 am.

A decision regarding afternoon activities will be made no later than 10:00 am.

A decision regarding evening activities will be made no later than 3:00 pm.

For Sunday Worship:

A decision will be made no later than 6:00 am.

To make an educated decision regarding Sunday morning worship, the Lead Pastor will consult with all Circle of Faith Parish pastors as well as each church council president. Each council president is encouraged to contact at least two (2) members of their council (preferably ones who live in different areas of the parish) in order to get a fairly clear picture of the road conditions. Each council president will report to the Lead Pastor along with their recommendation on the status of the worship services. The Lead Pastor makes the final decision. In the event that the Lead Pastor is on vacation or the position is vacant, the Associate Pastor and the Parish Council President will jointly make the final decision. If one of the Circle of Faith Parish congregations cancel, all worship services in the parish are cancelled.

If it is deemed necessary to postpone or cancel a(n) event(s) at Circle of Faith Parish, the following methods of communication will be utilized:

Kirsten Rabbe presented the Secretary's report for the November 17, 2014 Parish Council meeting. Motion by Jody Franck, seconded by Jon Helvig, to approve the Secretary's report as presented. Motion passed.

Joel Rabbe will email the November 2014 Operating Statement to the Parish Council. Motion by Jon Saxen, seconded by Marilyn Cheever, to approve the Treasurer's report, subject to review. Motion passed. Email any questions to Joe.

PASTORS' REPORTS

Pastor Anthony Christoffels

OLD BUSINESS

Insurance update

Jon Helvig reported that the information is in the hands of the "interpreter." He will report back when he gets the information.

NEW BUSINESS

Pastoral Designated Housing Allowance

Motion by Jon Saxen, seconded by Jon Helvig to approve the 2015 Pastoral Designed Housing Allowance as presented. This amount is strictly each pastor's individual choice, but needs to be recorded in the minutes in the form of a motion. Motion passed.

Medical Expense Reimbursement Plan

Pr. Anthony explained the IRS's change of heart in medical insurance reimbursement. The interpretation of the Affordable Care Act changed, and we were not notified of the change until fall, 2014. This change resulted in an additional expense of \$460 for Pr. Anthony, based on Circle of Faith's contribution to his health insurance. Note: Jon Saxen has requested that we keep on file in the office a denial of medical insurance. Pr. Anthony will provide that. Motion by Jon Helvig, seconded by Kirsten Rabbe to reimburse Pr. Anthony for the 2014 additional tax liability. Motion passed.

Motion by Jon Saxen, seconded by Jon Helvig, to approve the 2015 Medical Expense Reimbursement Plan for Circle of Faith Parish. Note: the Parish Council will have to do this every year in December. Pr. Anthony is currently our only full time employee, so this currently only affects him. Motion passed.

Candidate update - Changes in Parish Council

2015 candidates for Parish Council will be Karen Helvig from Waverly, and Deb Phillip from Trinity. Both congregational councils have approved these candidates, and they will be voted on at their congregations' annual meetings. St. Peter is still working on a candidate.

Thank you to Jon Helvig & Joe Rabbe, Liz Stahl, and their families, for the time dedicated to Circle of Faith for the past five years!

Steve thanked the Council – and wished everyone a Merry Christmas, and Happy New Year.

The next Circle of Faith Parish Council regular meeting will be January 13, 2014, 6:00 pm, at Trinity in Welcome. Motion by Joel Rabbe, seconded by Jon Saxen, to adjourn the meeting at 9:30 pm. Motion passed.

Parish Council Meeting Minutes

January 13, 2015

Meeting was called to order at Trinity Lutheran at 6:05 pm by President Steve Williamson. Other members present: Merle Burmeister, Marilyn Cheever, Jody Franck, Jon Helvig, Joel Rabbe, Kirsten Rabbe, Jon Saxen, Liz Stahl. Staff present: Pastor Anthony Christoffels, Pr. Eric Midthun.

Steve introduced Deb Phillip, Trinity's incoming Parish Council member.

Agenda: Pr. Anthony added one agenda item. Motion by Jon Helvig, seconded by Merle Burmeister, to approve agenda with one additional discussion item added by Pr. Anthony. Motion passed.

Pr. Anthony presented devotions based on Acts 2:41-47. Definition of fellowship: association amongst those who share an interest. What we all have in common is Jesus. It is because of Jesus that we are here. Our service here is because of this one common interest, as are our weekly worship services.

Kirsten Rabbe presented the Secretary's report for the December 18, 2014 Parish Council meeting. Corrections made: remove Merle Burmeister from attendees list, change adjournment time to 9:00 pm. Motion by Jon Saxen, seconded by Jody Franck, to approve the Secretary's report as corrected. Motion passed.

Joel Rabbe presented the December 2014 Operating Statement to the Parish Council, Motion by Jody Franck, seconded by Liz Stahl, to approve the Treasurer's report as presented. Motion passed.

PASTORS' REPORTS

Pastor Anthony's report

Pr. Eric will be at Continuing Ed in February for a week, including Sunday, February 8, 2015. We will need pulpit supply at Waverly for that Sunday. The parish council will explore pulpit supply options.

PRESENTATION OF THE ANNUAL REPORT OF THE PARISH

Joe presented the 2014 Operating Statement and 2014 Budget vs. Actual for Circle of Faith Parish. Joe also presented the 2015 Proposed Budget, recapped by category. Jon Saxen presented the Annual Audit of the Accounts for the Finance Committee. Jon reviewed all the reconciliations since February of 2013, and ran calculations of Bank Statements reconciliations. Up until now, voided checks were destroyed. In the future, Jon will ask the Parish Administrators to keep voided checks for the year, destroy them only after the audit. Motion by Marilyn Cheever, seconded by Jon Helvig to approve the audit as presented. Motion passed.

We watched Circle of Faith Parish 2014 Year in Review.

OLD BUSINESS

Insurance update

Jon Helvig presented the insurance update. Current vulnerabilities: COF has no liability coverage at all. Only coverage is through the individual congregations. Pastors are employed by Circle of Faith, which in turn contracts them to the congregations. Example of a potential issue: if one of our pastors went to the school to offer a prayer, and was hurt, we have no coverage. We also have no directors and officers coverage, and no sexual misconduct coverage. It would add \$500-1000 to the year to the Parish budget to add this coverage. Even though each congregation has listed Circle of Faith as an additional insured, it still doesn't completely cover our liability. Also, currently each congregation has it's own work comp policy. Maybe in the future, COF could offer one work comp policy, covering all the employees of COF and each congregation (pastors, parish administrators, custodians and organists) which could save each congregation money each year. Question: Would this policy cover our bulletin runners? Answer: These people are actually getting things for each congregation, so would be covered under the congregation's insurance. Discussion on exploring, at some point in the future, a joint policy covering all three congregations. Current issue: Circle of Faith Parish needs coverage. Joe suggested adopting one of the policies that that Jon brought as an example for the time being. Then the congregations can evaluate whether they would like to explore any additional coverage or a joint policy in the future. Would need to send it out for bids, which would require someone putting together a bid package. Blanket policy. Motion by Joel Rabbe, seconded by Jody Franck to accept option #2, including sexual misconduct/ molestation coverage for Circle of Faith Parish. This policy can be re-evaluated down the road, and changed at any time, but for the time being, we would be covered. Steve asked Jon Helvig to help the congregations put together a bid package, and be a liason to the congregations as we evaluate insurance coverage for the future. May or may not be feasible to change congregational insurance policies, just an exploratory process. Congregations suggested contact Roger Rezac at St. Peter, and Bocky Borchardt at Trinity to discuss. The insurance bid would be itemized by location. A joint policy could a) avoid disputes among the various insurance companies in case of a claim, b) provide a joint deductible, and c) may cost less overall. However, there are equally persuasive arguments against a joint policy. Jon Helvig agreed to work with the congregations to assess options. Motion passed. Jon will get this insurance policy bound for Circle of Faith, and Jon Saxen will be the new contact person for that policy in the future.

NEW BUSINESS

Approval of Parish Calendar and Synod Events

Motion by Kirsten Rabbe, seconded by Jody Franck to add the Southwestern Minnesota Synod Assembly dates for 2015 & 2016 to the parish calendar. Their dates are June 12-14, 2015, and June 11-13, 2016. Motion passed.

Lenten Schedule – Wednesday evening Lenten services will rotate among the congregations, with a meal before each service. 5:30 pm meal, 6:00-6:45 learning time, 7:00 worship. Pr. Eric & Pr. Anthony may offer an adult bible study from 6-6:45, this option still being explored. WOW (Worship on Wednesdays) will be "on the move", rotating between the churches with the Lenten services with a 6:00 or 6:15-6:45 pm learning time for the children.

Discussion on Ash Wednesday and Maundy Thursday services. After exploring options, the council recommended having joint services on for these two days at 7:00 pm. As with our Lenten services, the pastors will rotate them among our congregations each year. This will move First Communion for our young people from Maundy Thursday to Palm Sunday. Good Friday will be a joint service. This year, Circle of Faith and Partners in Ministry (Trimont) will offer a joint Easter Vigil worship service on Saturday evening at Trinity in Welcome.

Easter Sunday schedule: Trinity – 7:00 a.m., breakfast follows. Ceylon 8:30 a.m., Waverly at 10:30 a.m.

SWMN ELCA Bishop's meeting of all Area Parishes together will be Tuesday, January 27th at Synod office in Redwood Falls. Let Pr. Anthony know if you can attend.

Equipping Congregations will be held on Saturday, February 28th 8:30-3:30 pm, in Willmar. \$150 for the entire parish. As anyone who has ever attended will tell you, this is an amazing event, that both empowers and informs. Anyone interested in attending, please contact Pr. Anthony.

Parish Council Orientation/February Meeting

Pr. Anthony explained that Circle of Faith will hold an orientation for all Parish Council members at our February meeting. This will be to help define and differentiate parish vs. congregational responsibilities, and will be part of February meeting. Meeting will start at 6 pm, and because the meeting will be longer than usual, there will be no church council meetings that night. All Parish Council members, and Congregational Presidents will be included in this meeting. (Late note: supper will be served at this meeting.)

Proposed Parish Council Monthly Work Plan

Kirsten presented the proposed Parish Council monthly work plan. This places the requirements of the Parish Agreement into a calendar oriented format, listing items to be prepared and those to be presented each month.

Proposed Technology Fund

Pr. Anthony noted that we have a lot of technology that we run in our office. Things need to be replaced every few years. Pr. Anthony proposed that we set up a separate fund for the technology upgrades as they are needed. After some discussion, it was decided the incoming Parish Council will address this need. Steve and Pastor will review this, and make a recommendation to the council next month.

Discussion – Committee Assignments and Officers for 2015.

Decided that current officers will hold their responsibilities until the February meeting, when new officers will be elected from the Parish Council. This sets a precedence for each year to come.

Discussion item - same sex marriage.

As there are differing views on this concept in each of the three congregations, and sometimes differing views within a single congregation, we discussed how each congregation could make their own decision on this issue, and still respect the ability of the other congregations to make a different decision. Emphasis was placed on avoiding a split in the parish, or in one congregation, based on this issue. We recognize the strong feelings on both sides of this issue. We also recognize that while Circle of Faith congregations may share some things, each congregation is still autonomous, and free to make their own decision on this matter. We need to respect the differences in our congregations, and allow ourselves to learn from each other. President Steve commended the Council on the high level of discourse, and the professional manner in which the discussion was held.

On behalf of Circle of Faith Parish, President Steve thanked Jon Helvig, Joe Rabbe, and Liz Stahl for the time they have dedicated to Circle of Faith for the past five years! In August 2010 this journey began. There have been at least 60 meetings that all members have attended. Steve thanked them for their contributions, insight, and dedication. "You set a great example." The council concurred.

The next Circle of Faith Parish Council meeting will be February 10, 2014, 6:00 pm, at Trinity in Welcome. This meeting will include orientation for the Parish Council, and there will be no Congregational Council meetings that evening. Motion by Jon Helvig, seconded by Jon Saxen, to adjourn the meeting at 7:37 pm. Motion passed.

Seminarian's Letter Home

To the membership of Circle of Faith Parish:

Greetings to you all from Evanston, IL! Seems like we're back in familiar territory, doesn't it? On February 18, we come back to the place from which we try to flee, and to which we always must return – Ash Wednesday, the forty days we call Lent. Try though we may to escape this journey into the wilderness with Christ, we can't get away from it. And it always starts with those haunting, scary words: "Remember that you are dust, and to dust you shall return." So much for our sharing, our rejoicing, and our fellowship now, if all we have left is to turn to dust and ashes

Ancient Christians knew the power of ashes well, and often used them as a sign of penitence, as we do today. But they had another symbol that went with it. On many early Christian graves, you can see carvings of a mythical bird called the phoenix. According to legend, this bird, when its time came to die, would build a nest of cinnamon twigs, which it would then set on fire. From the ashes, in time, a new phoenix – a beautiful bird with spectacular red and gold feathers - would be born. One early writer named Clement of Rome said that the phoenix was put on tombs to claim our hope of resurrection. After all, he says, if a *bird* can live again after dying so utter a death, then why can't we, through the grace of God?

On the night before Easter, be sure to come when Circle of Faith and Partners in Ministry celebrate together, for the first time for many of us, the liturgy we call the Easter Vigil. On that night, what begins on Ash Wednesday ends in a powerful opposite. What begins in ashes will end in new flame. What begins in desert and fasting will end in a generous splash of baptismal water, and a feast of everlasting life. What begins in silence will end in alleluia. What starts in the cold and dark of winter will find its end in the bloom of spring. You won't want to miss something that wonderful. Renew us in the gift of baptism, that we may provide for those who are poor, pray for those in need, fast from self-indulgence, and above all, that we may find our treasure in the life of your Son, Jesus Christ our Savior and Lord. Amen. [ELW, Ash Wednesday]



HYMN OF THE MONTH

As we approach the Lenten season and the time of The Ultimate Sacrifice, this is time to remember the Negro Spiritual "Were You There". It is a graphic description of the events of Good Friday. It was likely composed by African–American slaves. It first appeared in 1899 in 'Old Plantation Hymns'. In 1940 it was included in the Episcopal Church hymnal, making it the first spiritual ever to be published in a major hymnal. It was a favorite of Mahatma Ghandi, and has been recorded by many artists, including Harry Belafonte and Johnny Cash. A quote from W. J. Petersen's book, "The Complete Book of Hymns" describes it better than any I have ever read: "This hymn, like few others, puts the singer "there". "Were you there?" We experience the "tremble" as we sing it. It is stark reality. We hear the nails pounded into the cross, we see the onlookers wagging their heads, we smell the burial spices – and we tremble, tremble, tremble."

In one rendition of the song the negroes had added another final verse: 'Were you there when He rose up from the dead? Were you there when He rose up from the dead? O! Sometimes I feel like shouting glory, glory, glory! Were you there when He rose up from the dead?' Doesn't it make you feel like you WERE THERE feeling the stone rolling away, and you tremble, tremble.
